## MINUTES

### **ROLL CALL & QUORUM:**

Roll was called (see Attachment A), which resulted in 17 eligible representatives. This equated to 69.5 % of the current participation percentage being in attendance, which is greater than the 50% needed to have a quorum of the Reservoir Committee.

### **CALL TO ORDER:**

Chairman Bettner called the meeting to order at 9:30 a.m., followed by the Pledge of Allegiance.

### **INTRODUCTIONS:**

The Sites Reservoir Committee members, staff, and members of the public introduced themselves.

It was motioned by Traynham and seconded by Hartwig to approve the July 20, 2018 Agenda as revised. Motion approved unanimously.

**2. Manager's Report:**

Watson

2.1 Discussion and possible direction to staff regarding the General Manager's monthly status report (***Attachment 2-1A***).

General Manager Watson updated the Committee regarding activities during the month of June 2018 as follows:

- Phase 2 finance plan and work plan,
- Phase 2 Reservoir Project Agreement and development of the process and documents needed to procure resources at the start of Phase 2,
- Continuing work on the USDA loan application,
- Engaging with the Water Commission regarding the WSIP application and with the Reclamation on requirements for application for potential WIIN Act funding.
- Engagement and Outreach: continuing to coordinate with landowners, media outlets, state and federal elected official, radio program (Rice Commission),
- Feasibility Report (ready end of August 2018),
- Department of Energy grant application for technical assistance for hydropower.

2.2 Discussion and possible direction to staff on State (Prop 1 WSIP application) and Federal (WIIN Act) Funding (***Attachment 2-2A***).

General Manager Watson updated the Committee Members on the Prop 1 WSIP application, the June 18, 2018 Authority Meeting, June 27, 2018 Water Commission Meeting, July 24, 2018 Water Commission conditional funding decision (Maximum Conditional Eligibility Determination\_, repayment of loan for Phase 2, and execution of agreements. Discussion followed regarding funding of project, early funding and federal funding with no action taken.

General Manager Watson provided an overview on the Federal WIIN Act Funding. Discussion followed regarding the Feasibility Report, CalFed Funds, Alternative D, and the Phase 2 work plan with no action taken.

General Manager Watson provided an overview of the various agreements that need to be updated or developed either prior to the start of or during Phase 2 with no action taken.

2.3 Report on the July 16, 2018 Sites Project Authority Board of Directors Meeting (***Attachment 2-3A***).

General Manager Watson provided an overview of the July 16, 2018 Sites Project Authority Board of Directors Meeting and items approved and/or accepted.

2.4 Consider approval to submit the USDA Rural Development Community Facilities Loan application and to authorize the General Manager to sign and submit.

**Action:** It was moved by Vanderwaal and seconded by Hartwig for conditional approval of the Phase 2 Work Plan. Motion approved unanimously.
