# GOVERNANCE AND INTERNAL ORGANIZATION

# **Report on General Manager Proposal**

GCID General Manager Thad Bettner reported that the General Manager Request for Proposal/Qualifications (RFP/Q) was distributed for advertisement. The RFP/Q has been posted on the Association of California Water Agencies (ACWA) website and will be advertised in the January issue of the ACWA News. Dan Keppen, executive director for Family Farm Alliance, dispersed the advertisement to the Family Farm Alliance Directors and Advisory Committee Members. It will also appear in the next issue of the Irrigation Leader magazine, and Northern California Water Association (NCWA) will publish it in the NCWA Week in Review.

The deadline for any interested parties to submit a proposal is April 3, 2015.

# REGULAR BUSINESS Committee Reports

## **Coordinating Committee**

The Coordinating Committee continues to meet at their standing meeting.

## **Outreach Committee**

Alternate Director Evans reported that the committee is waiting to review the information gathered from the public meetings that is being compiled by consultant, Dave Ceppos and will then move forward on planning the next set of public meetings.

# Outreach to Conservation and Environmental Non-Governmental Organizations (NGO)

Director McDaniel said that Congressman Garamendi and Congressman LaMalfa would like to meet with Sites JPA representatives to discuss plans to move the project forward. A mid-February meeting is in the planning stages.

## Water Users/Investor Committee

Director Vann reported that there has been a great response from North State water users, who have submitted letters of interest totaling 43,000 acre-feet. They anticipate receiving more letters of interest in upcoming months.

Discussion took place on potential investors and contributions by investors to be used for finalizing planning efforts. Investor inquiries regarding assurances that their money will

be spent on activities to reach the goal of obtaining water from Sites Reservoir was also discussed, in addition to the need for further definition related to a process to allow for their participation in the governance process.

To provide these assurances would require the Board to review the Sites Governance Agreement. Additionally, an Investor Contract to receive and use their funds would help in the process of building the investor base. The Board directed Attorney John Kenny to bring suggestions to the next board meeting on what changes may be needed to the Governance Agreement and what an Investor Contract might contain for prospective investors. The Board also asked Attorney Mark Atlas, legal staff for the TCCA, to assist Mr. Kenny as needed on this project.

The Investor Contract will need a baseline Sites JPA Work Plan to show where the monies would be used. GCID General Manager Thad Bettner was requested to bring a revised Work Plan back to the next Board meeting for review.

TCCA General Manager Jeff Sutton reported on the Federal budget cycle for the coming fiscal year, and efforts to have \$1.5 million appropriated to the Sites Reservoir Project for planning, feasibility studies, and environmental documents. He requested that the JPA Board support the pursuit of these additional funds in the Federal budget. The Board agreed and, if a special board meeting was necessary between now and the March meeting to assist on this effort, one would be scheduled.

## **General Managers Group**

RD 108 General Manager Lewis Bair reported regarding interest expressed from California Fish and Wildlife to start discussions with the Sites JPA as Proposition 1 storage funding regulations begin to be developed by the California Water Commission. He will schedule a meeting with Chuck Bonham and Director McDaniel will attend.

They will be working with U.S. Bureau of Reclamation to review the draft MOU Scope of Work and draft Project Management Plan.

#### **OTHER BUSINESS**

There is an outreach planning meeting on February 9, at the Capitol, hosted by Senator Nielson and Assemblyman Gallagher to generate awareness and support for the Sites Reservoir and to provide information to assist on the Proposition 1 funding process. Director McDaniel plans to attend.

The next board meeting will be on Wednesday, March 4, 2015, at Yolo County Flood Control and Water Conservation District, Woodland.
