GOVERNANCE AND INTERNAL ORGANIZATION

Receive Report and Discussion to Provide Input on Revisions to the Sites Project Authority Joint Exercise of Powers Agreement

Counsel John Kenny and TCCA General Manager Sutton reviewed the revisions to the Agreement for the sections related to the supermajority voting requirements. The supermajority vote appears in five sections of the Agreement. Counsel Kenny and TCCA General Manager Sutton will finalize the changes to the Agreement and will send it to board members for final review.

Review, Discussion and Possible Approval of Final Contract to Hire General Manager Vice Chair Durst reviewed the contract. The General Manager would be hired as an individual contractor for Sites JPA. Discussion followed regarding the change from an employee hire to an individual contractor. The contract to hire as an individual contractor will be sent to the Board for final review.

Chair McDaniel will call a Special Board Meeting, to be held on Wednesday, July 15, 2015, 1:30 p.m. at Westside Water District, to approve the final contract to hire the General Manager.

Protocols, Conditions and Procedures for Addition of New Board Member Seats Six of the seven member agencies have approved the addition of four new board member seats. YCFC&WD's next meeting agenda will include an agenda item for action on the possible approval of the new members. The new members would be Colusa County Water District, Orland Artois Water District, Proberta Water District and Westside Water District. Each new member would pay the initial membership dues of \$5,000 and appoint a Director and an Alternate Director.

Discussion and Direction for Executive Committee Duties

Chair McDaniel has established an Executive Committee that would include the Sites JPA Chair, Vice Chair and Secretary/Treasurer and to have a standing meeting at 2 p.m. each

Monday at GCID office in Willows. The meetings will begin in August and include the General Managers' Technical Group as support staff.

Report on U.S. Bureau of Reclamation and Department of Water Resources MOU Status

The MOU with the U.S. Bureau of Reclamation (USBR) has been signed by the Sites JPA Chairman and returned to the USBR for their signature. The Department of Water Resources (DWR) letter has been sent to DWR, no response has yet been received.

General Managers' Technical Group Report

The General Managers' Technical Group and consultants have been working on planning, budget and a timeline. Scott Brown of Larsen Wurzel & Associates, Inc., presented a draft budget for review to the Sites JPA Board members and the proposed four new Board members.
