## **Approve Treasurer's Report**

## **Discuss Budget Preparation and Assumptions for 2015**

Jim Bond reported that he and GCID General Manger Thad Bettner would prepare a multiyear budget with two scenarios; one for when the Water Bond passes and one if it does not pass.

# GOVERNANCE AND INTERNAL ORGANIZATION

## **Report on General Manger Proposal**

The draft Request for Qualifications (RFQ) and Proposal for General Manager was discussed at length. Concern was raised on how to fund the General Manger position as the burden of financing the position would be up to the members if the Water Bond does not pass in November. The job requirements will be different if the Water Bond does not pass versus the requirements needed for a General Manager if the Water Bond does pass.

Director McDaniel arrived at 1:46 p.m.

The question was raised that if the RFQ is delayed in sending out until after the Water Bond, and assuming it does pass, that it may be expected to contain a higher financial offer than if the RFQ was sent out prior to the elections.

Director Bransford arrived at 1:53 p.m.

Director Denn departed at 1:54 p.m.

It was suggested that the timeline for the RFQ could start in mid-October with the RFQ's being received from interested parties by late November.

Director McDaniel moved to approve the Request for Qualifications proposal for General Manager, Director Tadlock seconded the motion, and the motion was unanimously approved by the following vote:

# **Review and Approve Legal Services for Power Permitting**

The General Mangers Group invited attorneys to discuss legal authorities and permitting related to the power attributes of the project. Two firms have provided "Proposed Scope of Work" and they were reviewed by Attorney John Kenny.

Attorney Kenny found both Scopes of Work (SOW) to be in order and acceptable if the Sites JPA wished to proceed. Both SOW offered specific "not-to-exceed" clauses for specific tasks.

Director Vann moved to approve the specific tasks in the Proposed Scope of Work from Braun Blaising McLaughlin & Smith P.C. \$3,500 and Holland and Knight LLC \$6,000, Director Bransford seconded the motion, and the motion was unanimously approved by the following vote:

Review Responses to Sites Reservoir Services and Benefits Questions by Members Dave Ceppos, Center for Collaborative Policy, provided a summary of each members' responses to the Sites Reservoir Services and Benefits Questionnaire. The commonality issues with members were infrastructure, to support power, and water pricing. The Board discussed the many ideas formed for the questionnaire as it provides direction to the Board which of the alternatives would be most beneficial to all members to use in building of Sites Reservoir.

Comments from others present at the Board meeting included the impression that ninety percent of the water would be used by southern California, such as Los Angeles. The public also expressed the desire to improve public understanding of the environmental benefits that Sites Reservoir will provide.

# Report and Discussion on Federal Affairs

GCID General Manager Bettner reported the Coordinating Committee has been working towards a Memorandum of Understanding (MOU) with the U.S. Bureau of Reclamation (USBR) to complete the Feasibility Study (FS) and/or follow an approach similar to Los Vaqueros Reservoir where Sites JPA would be the lead and there would be an operational and permitting relationship with USBR. USBR has rejected this, stating that Congress has not authorized the second approach.

Further discussion on Federal Affairs was tabled to the next meeting.

# **Committee Reports**

# **Coordinating Committee**

The Coordinating Committee continues to meet each Tuesday.

#### **Outreach Committee**

Landowner and interested parties were invited to attend any of the ten meetings that were held mid-September with the last meeting held on September 29, 2014. Various concerns included fair compensation, treatment of burial grounds and cultural resources, land use and access requirements and restrictions, local availability of water resources, area of origin, use and distribution of water, benefits and drawbacks of recreation, location of the pipeline and the right-of-way protocols and easements.

The Committee feels that the local landowners' questions and concerns were addressed and is planning to hold additional outreach meetings after the November election.

# Outreach to Conservation and Environmental Non-Governmental Organizations (NGO)

Director McDaniel has been working with TCCA Consultant Mike Urkov on a presentation to show the environmental benefits of a Sites Reservoir to present to the various NGO's. They would like to have everyone stay after the meeting to review the presentation.

## Water Users/Investor Committee

Director Vann said the Committee has developed goals to meet Early Action Planning Dollars: Identify short and long term water users that would participate in Early Action Planning Dollars; obtain messaging points from other committees and the Board to incorporate into the messaging points of why water users should participate in Early Action Planning Dollars; coordinate the Action Plan into future definition of what Early Action Planning Dollars will be used for and timing; coordinate results of Sites Reservoir Services and Benefits Questionnaire into the talking points asking for funding of Early Action Planning Dollars.

URS Consultant Jeff Herrin distributed the schedule of work in progress.

#### OTHER BUSINESS

The Water Education Foundation will be conducting its Northern California water tour to Glenn-Colusa Irrigation District on October 24. The Sites JPA Board is welcome to join the tour at GCID's Main Pump Station for lunch. They will also be stopping at the Refuge and Sites Reservoir site.
