Subject:

Phase 2, Amendment 3 High-Level Cost Estimate

Requested Action:

Review and comment on the Amendment 3 work plan early budget estimates and cash flow for the 18-month and 36-month work periods.

Detailed Description/Background:

Staff has continued the development of the Amendment 3 Work Plan by preparing a high-level cost and cash flow estimate based on the Authority's work plan goals and objectives. In general, the total of the high-level budgets for each of the subject areas is consistent with previous presented high-level Amendment 3 estimates of approximately \$100 million dollars for an 18-month work plan and higher for a 36-month work plan, currently estimated to \$112M.

The 18-month work plan will accomplish all the Amendment 3 goals and objectives and aligns with the previously discussed estimated \$350/af cash call. The 36-month work plan also accomplishes the same goals and objectives and completes critical activities within the first 18 months such as securing the water right permit, CDFW incidental take permit, and Federal Biological Opinion. This aligns with the previously discussed estimated \$400/af cash call. However, as previously discussed, after the first 18 months the Authority may decide to secure bank financing for the remaining 18 months.

Graphs of high-level monthly estimated expenses and revenue funding (i.e., cash calls, WSIP, and WIIN) were prepared for the 18- and 36-month work plans and both graphs indicate that there appears sufficient revenue funding to meet the estimated monthly expense "burn rates". However, further analysis needs to be conducted to determine the exact scheduling and amounts of each individual cash call.

Currently, the most significant expense activities are engineering work needed to secure key permits and geotechnical investigations which together account for approximately half of the total Amendment 3 expenditures. Attachment A provides working draft subject areas pie charts for the 18- and 36-month work plans.

Staff will be proposing budgets for each of the subject areas which will be the line items that the Authority will be managed to and apply the delegation of authority matrix when changes occur.
