Subject: Revised Conflict of Interest Code

Requested Action:

Consider approval of the Sites Project Authority amended Conflict of Interest Code (COI) and to direct Authority staff and consultants to take such actions as are necessary and appropriate to process and finalize the code.

Detailed Description/Background:

The Sites Project Authority has initiated a proposed update to its COI Code (Code) to reflect recent changes in the organization's management structure and the addition of new positions that are proposed to be "Designated Positions" under the COI.

The amended Code makes minor technical edits including renaming the positions of General Manager to Executive Director and Local Coordination Manager to External Affairs Manager as well as changing the title of "Legal Counsel" to General Counsel and "Bond Counsel" to Bond & Disclosure Counsel.

In addition, the amended Code would add five additional "Designated Positions" that will be required to submit Statements of Financial Interests (Form 700). These include the Engineering & Construction Manager, CEQA Permitting Counsel, Water Right Counsel, Real Estate Counsel, and Agency Agreements Counsel.

With approval of the draft of the Code, Authority staff will distribute a Notice of Intent and the proposed amended Code via email on September 16th to all Authority Board members and alternates as well as Reservoir Committee participants and alternates, and others holding Designated Positions.

The Authority will establish a comment period commencing on September 16, 2022, and closing on November 1, 2022 to solicit feedback from effected parties regarding the proposed amended Code.

At the closing of the comment period, Authority staff will address any comments received from the members, participants or holders of designated positions. Once completed, Sites General Counsel will submit the approved draft of the amended Code to the California Fair Political Practices Commission for review and final approval.

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs.
