## Final EIR/EIS Briefings in Preparation for Approval of Project

- February 2023, Part 1

#### **CEQA/NEPA Joint Document**

- CEQA and NEPA are similar in intent and process but have key differences that require careful coordination
- Since 2017, the Authority has worked closely with Reclamation to prepare the EIR/EIS
- Focus of our briefings to date has been on the CEQA components of the Project
- As a joint CEQA and NEPA document, the Final EIR/EIS also requires approval from the federal government prior to publication

#### **Federal Review Process**

- Final EIR/EIS is currently undergoing Reclamation Regional Management review
- Next steps include:
  - 1. Review in Reclamation's DC Office along with the Department of Interior (DOI) Assistant Secretary of Water and Science and the DOI NEPA Review Team
  - 2. U.S. EPA publication of a Notice of Availability (NOA) of the Final EIS in the Federal Register
- Authority will publish the Final EIR/EIS on its website once Reclamation is authorized to move forward with the NOA publication

#### **Record of Decision (ROD)**

- Activities to be completed prior to Reclamation signing a ROD:
  - Final EIS available to the public for 30-days
  - Completion of National Historic Preservation Act, Section 106 process (cultural resources)
  - Completion of Endangered Species Act compliance
- ROD currently anticipated to be signed in mid- to late-2024

#### **Section 106 and ESA Compliance**

- Section 106 process is ongoing
  - Authority and Reclamation have drafted a Programmatic Agreement (PA)
  - Reclamation submitted the draft PA to the State Historic
    Preservation Officer (SHPO) in March 2022 for review and input
  - SHPO has not yet responded with comments
  - Elevating status to Strike Team for assistance
  - Once SHPO responds, Reclamation revises, then another round of comments and input from all parties
  - Reclamation then finalizes PA and it is complete once Reclamation and SHPO have signed
    - Authority and U.S. Army Corps also "Invited Signatories" but our signatures are not necessary to complete Section 106
- ESA compliance is underway
  - Update was provided at the June 2023 meeting, no changes in approach or schedule have occurred since June

    - Tribal considerations with MOA and Tribal Working Group
