Happy Friday!

Here are the Historic Land Use Conversion Tables that you requested for Colusa, Glenn, Yolo, Tehama, Stanislaus, and Merced Counties. These tables span from the date of initial mapping of the county (varies) to either 2016 or 2018, depending on whether 2018 mapping has been completed for the given county. Note that some of these excel files have multiple tabs that cover specific timespans due to an expansion of acreage mapped.

I will send you the field reports for the corresponding counties on Monday since I am off work today. However, I should mention that no field reports exist prior to 2002 since they are not a mandated product. So, we simply did not produce them before that year. And, unfortunately, we are ceasing to produce county field reports as of 2018 due to program capacity limitations.

Do you need field reports for all of the counties for the 04-06, 06-08, 14-16, and 16-18 years? Or just for some of the counties?
